
X-TREMELY INTELLIGENT ROUTING AND ACCESS


X-TREMELY FLEXIBLE BILLING CAPABILITIES

The XMS architecture enables post-paid rating through CDR generation and pre-paid rating through direct interactions between the X-treme Push Gateway and a pre-paid system.
