

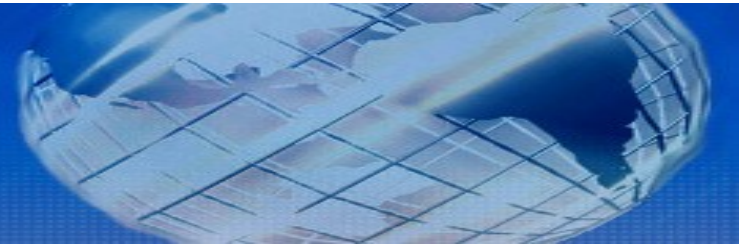

Imagine if:

- your government forced you to buy a word processor from a specific vendor so that you could interact with it electronically
- important historical documents were no longer readable because the vendor whose software created them arbitrarily changed the format used to save the document; or
- in times of emergencies, government agencies could not communicate efficiently because they used different word processors that used proprietary, non-standard formats or a format dictated by one vendor.



What Is ODF?

- XML-Based specification for displaying and storing data files
- Only available open, vendor-neutral, standardized format for office applications
- Provides perpetual access to documents, independent of the applications that created them
- Approved by OASIS in May 2005 and continues to be advanced in OASIS
- Approved by ISO/IEC as international standard in May 2006
- ODF v1.1 incorporating accessibility enhancements approved – Oct 2006



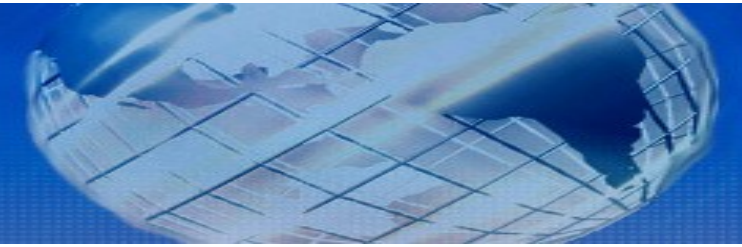
ODF Is An Open Standard

- Developed, maintained and controlled by an open standards organization with cross industry and open source community involvement
- Published without restrictions or royalties
- Freely available for adoption by industry
- Available in multiple competing interoperable implementations on multiple platforms

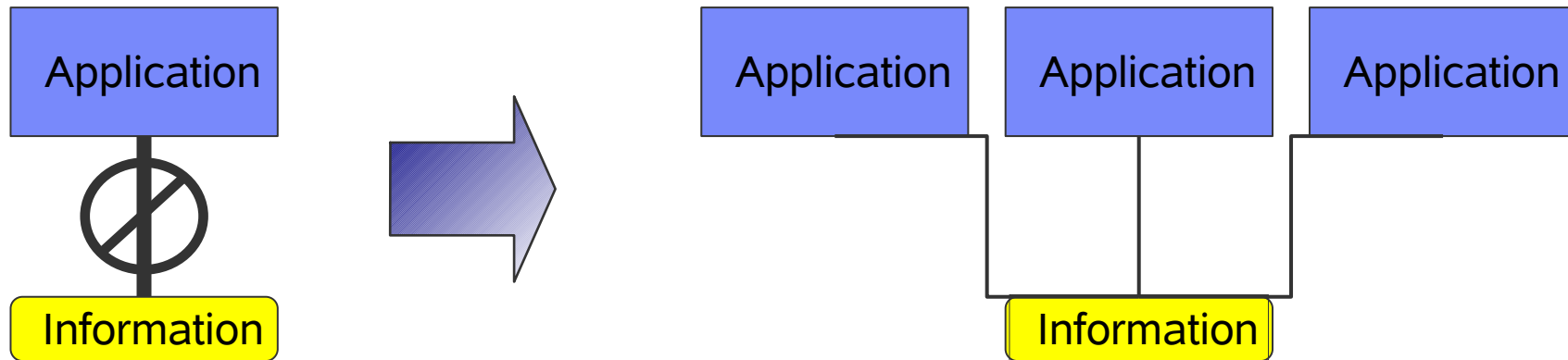

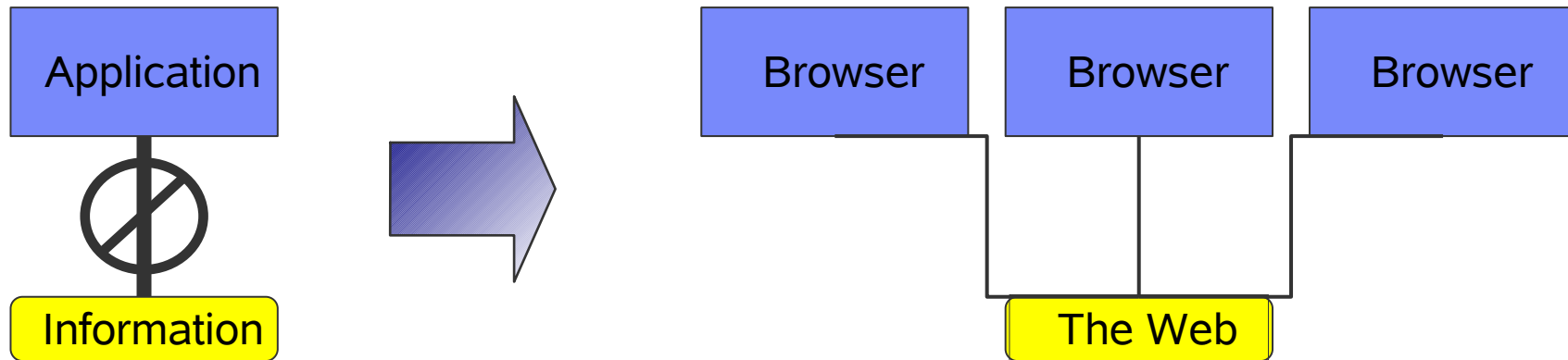
New Style

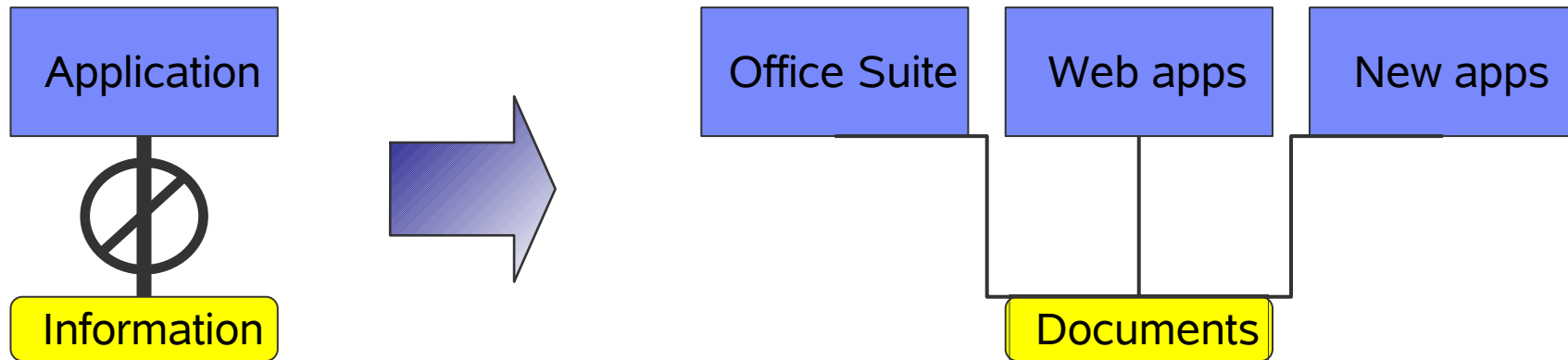

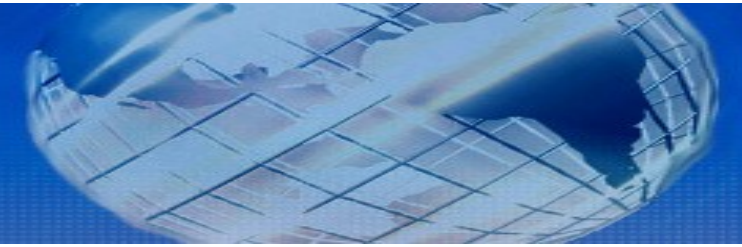

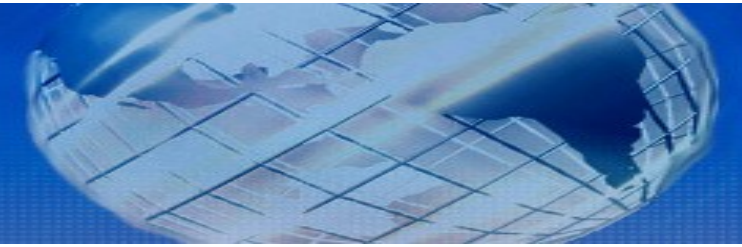
ODF: Who's Using It?

- **Massachusetts leads way in U.S.**
- **Takes off in Europe**
 - Belgium, France, Denmark, Norway
 - Regions of Spain, Bristol City Council (UK)
- **Gains foothold in Asia**
 - Malaysia, India, National Desktop on Indonesia, others looking to move?
- **Latin America**
 - Brazil, others?



Case of Massachusetts

- Open standards policy – Jan 2004
- Enterprise Technical Reference Model (ETRM) calls out ODF – Sep 2005
- On track for Jan 2007 implementation
- Policy update to ensure needs of persons with disabilities met – Aug 2006



Belgium

- **Council of Ministers decision – June 2006**
 - ODF chosen as standard for document exchange between govt administrations
- **Implementation – phased approach**
 - Reading functionality by Sep 2007
 - Document exchange by Sep 2008



France

- **RGI (Interoperability Guidelines) – Dec 2005**
 - Recommended to use document format based on XML that is vendor-neutral, open, and royalty free
 - Recommended to use ODF for office applications (text, spreadsheets, presentations)
 - Required to accept all documents in ODF
 - Prohibited to migrate to a format used by only one organization
- **Implementation**
 - Comment period – Aug 2006
 - Final – Dec 2006



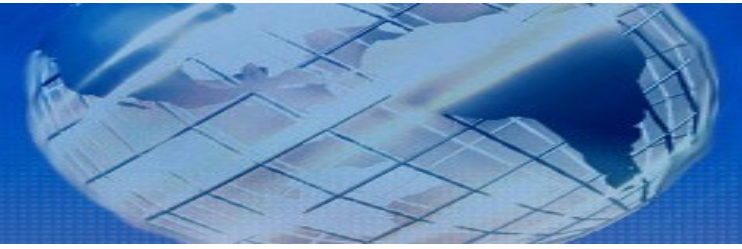
Denmark

- **Parliamentary decision – June 2006**
 - All digital information exchange based on open standards by June 2008
 - Obligation to introduce and maintain set of open standards
- **Implementation roadmap under discussion – Sep 2006**



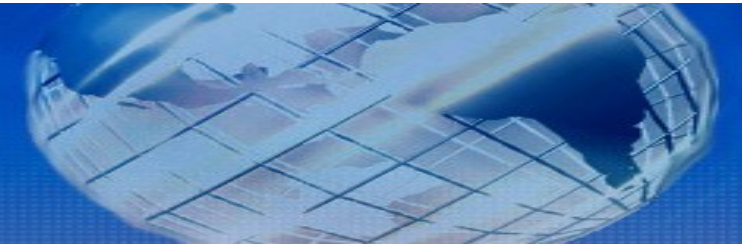
Others in Europe

- Spain: Extremadura to use only ODF and PDF for read-only – July 2006
- Italy: Adopts ODF as a national standard
- Norway: eNorge 2009 all communication between govt and citizens based on open formats; IT systems based on open standards
- Croatia: eHrvatska govt plan to generate and archive digital content using open formats



Malaysia

- National standards body votes to propose ODF as country standard – July 2006
- Public comment period – Sep 2006
- Ministry of Science, Technology, and Innovation expected to endorse ODF for use by public sector by year end



India

Gov't Agencies Adopting ODF

- Allahabad Courts
- Government of Delhi
- Department of Tax, Delhi
- Life Insurance Corporation (govt entity)
- Indian Army
- Election Commission



Others in Asia

- Hong Kong: ODF becomes a recommended standard
- Thailand, Japan, China: among 13 nations to endorse paper supporting solutions based on open standards

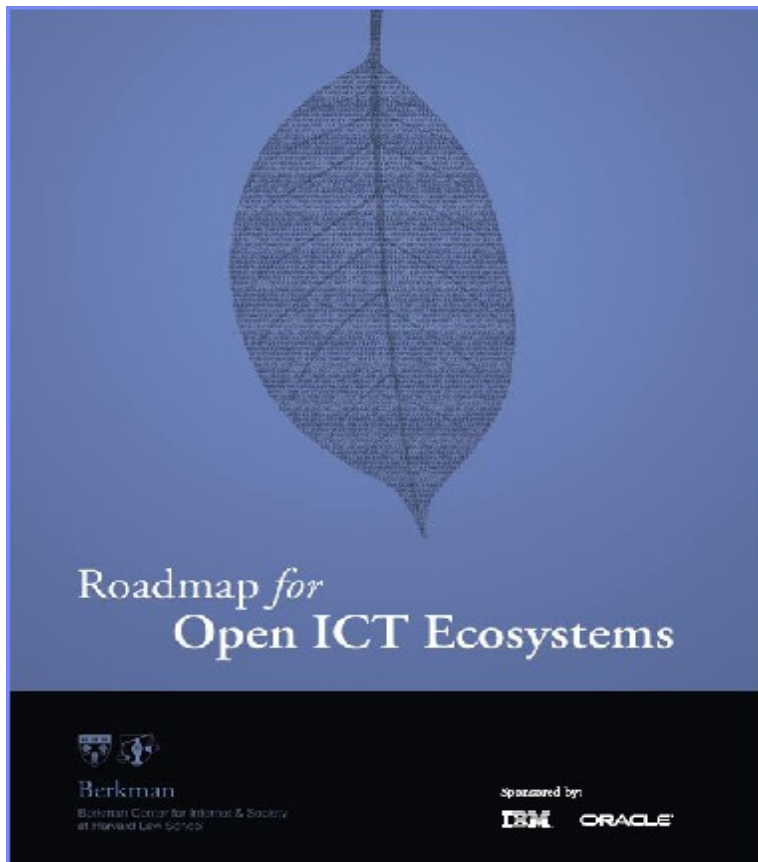


Brazil Goes ODF

- ePING v2.0 Interoperability Framework (Nov 2006)
- ODF is recommended government standard
- .doc, .xls, and .ppt designated “in transition” - do not comply with Brazil's technical policies

Plan by 13 Nations Urges Open Technology Standards

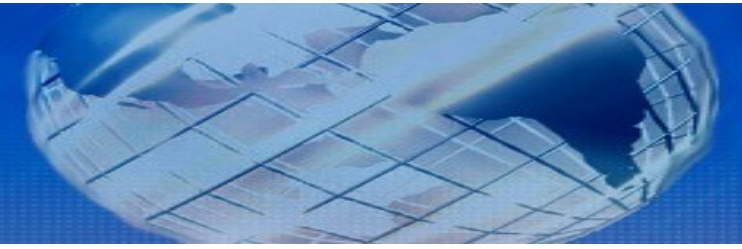

In a report to be presented at the World Bank today, a group that includes senior government officials from 13 countries will urge nations to adopt open-information technology standards as a vital step to accelerate economic growth, efficiency and innovation.

The 33 page report is a road map for creating national policies on open technology standards, and comes at a time when several countries - and some state governments - are pursuing plans to reduce their dependence on proprietary software makers, notably Microsoft, by using more free, open-source software.



ODF Adoption Conclusions

- Gartner: 50 percent of governments and 20 percent of commercial organizations will require ODF by 2010 (0.7 probability)
- No “one size fits all” approach to adoption



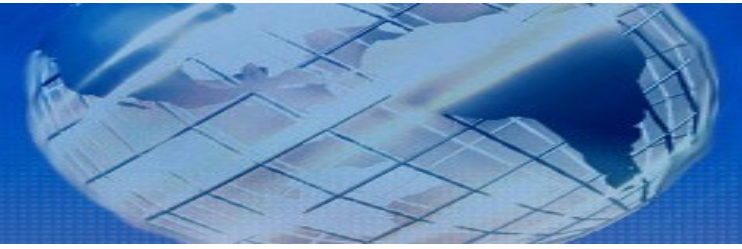
What About Cost Savings?

- **Bristol City Council (UK)**
 - Cut software costs by 60% over 5 years in switching 5500 desktops to Star Office
- **Denmark**
 - 550m kroner, or \$94m, over a five-year period in move to OpenOffice (Ramboell Report)

Open Document Best Practices

- Check the default save format
- Ask about proprietary tags to XML specifications
- Understand modification consultation procedures
- Ask for inter-platform portability
